- b. Hawaii County Council and Fire Department contributions (Leasing contract with Hawaii County and insurance). Discussed as well. New main tank will take weeks to months to be replaced. Our councilman, Matt Kaneali'i-Kleinfelder, has dedicated \$7,500 towards new tank and will ask county fire department to contribute the other half of funds. This has to go through committees, etc. Motion to allocate funds up to \$2,500 for a small tank just for the community center was made by Jim Hoffman and seconded by Pam Everett. Motion carries
